**National Horticultural Research and Development Foundation (NHRDF)**, established on 3<sup>rd</sup> November, 1977 under Indian Societies Registration Act, 1860 having its head office at Bagwani Bhawan, Plot No. 47, Institutional Area, Pankha Road, Janakpuri, New Delhi - 110058, hereby invites Expression of Interest (EOI) from prospective Manufacturers/Authorized Suppliers for Supply of Agri/Horti Inputs including Bio Inputs, Micro Nutrients, Plant Growth Promoters/Regulators, Machinery, Equipments and Implements and Technology Interventions like Block Chain, Crop mapping, Drone Technology, etc., to Central/State Governments/ Government Organizations/Agencies and other Buyers (hereinafter called as “Customer” or “Customers” as the case may be). The details of items covered under this EOI are as under:

**1. Inputs and Items for which EOI is invited:**

- (i) Biofertilizers.
- (ii) Organic Manure
- (iii) Micro Nutrients.
- (iv) Bio-pesticide, Bio-insecticide, Bio-fungicide.
- (v) Plant growth Promoters/Regulators.
- (vi) Pheromones/ Light Traps/Shade Nets/ Fruit Covers/ Anti Hail Nets/Solar Fencing.

**2. Scope of work:**

(i) The empaneled manufacturers/authorized suppliers shall accept all the terms and conditions of Customers and shall undertake the supply of said products and commodities to the Customers in the manner required. The manufacturer/authorized supplier shall also furnish Interest Free Security Deposit, if any, as required by customer.

(ii) NHRDF, will quote the rates to Customers on the basis of rates offered by the manufacturer/authorized supplier after adding Service Charge of NHRDF. The terms and conditions including quality, quantity, delivery schedule etc. of the order received by NHRDF from customer shall be applicable to the manufacturer/authorized supplier and the same shall be accepted by the manufacturer/ authorized supplier in writing. NHRDF shall not make any financial investment for execution of the order nor NHRDF shall have any financial liability arising out of the transaction at any stage. It shall be the sole responsibility of manufacturer/ authorized supplier to execute the order received from customer on behalf of NHRDF.

(iii) It is to be expressly understood and agreed by the manufacturer/authorized supplier that NHRDF shall be making the purchases on behalf of its Customers and NHRDF shall be liable to make payment to the manufacturer/authorized supplier only after receipt of the same from Customer. It shall be the responsibility of the manufacturer/ authorized supplier to realize payment from the customer and NHRDF in no way shall be responsible for the same. In case any deductions are made from the bills of NHRDF by its Customers on account of deviations in the specifications or due to shortage(s) or for any other reason, the same shall be recovered/debited to the account of Manufacturer/Authorized Supplier.

### **3. Pre-qualification Criteria for Applicants:**

- (i) Certificate of Incorporation/ Registration as Manufacturer/Authorized Supplier
- (ii) Proof of average annual turnover of Rs two crore during the last three financial years or Startup India Certificate.
- (iii) Minimum three (03) years' experience of supplies of any one or more of above inputs, whereas in case of Start Ups minimum experience should be of at least one (01) year.
- (iv) Valid Manufacturing License of respective products from concerned Government Departments/Authorities/copy of Authorized Agency Agreement/License for the same.
- (v) Organic Certification (if any).
- (vi) ISO Certification (if any).
- (vii) Company's PAN and GST number.
- (viii) The prospective applicant should not have been blacklisted / banned by any Central/ State Government Departments/PSUs/Autonomous Bodies.
- (ix) NHRDF may conduct inspection of the Manufacturing Unit of Manufacturer/Authorized Supplier godown/office before final empanelment to ascertain that the company is having modern Plant & Machinery and active supplies.
- (x) If manufacturing and supply companies are different yet under the same entity then provide relationship proof between the companies.

### **4. Documents Required:**

The Security Deposit shall be in favour of National Horticultural Research and Development Foundation (NHRDF). Selected Party shall not receive any interest on the Security Deposit paid to NHRDF. Security will be refunded upon termination of association after agreed period. However, in case of breach of agreement security may be forfeited. **6. Submission of Expression of Interest:**

- i. Intending Manufacturers/ Authorized Suppliers may download Application Form for EOI from [www.nhrdf.org](http://www.nhrdf.org) and shall submit Expression of Interest documents in original down loaded form, duly signed and stamped at each page. Expression of Interest received over Fax/Email or copy of the Expression of Interest shall be summarily rejected.
- ii. The Expression of Interest must contain the Name, Designation and place of Business of the person with Phone and Mobile Nos. of person making the Expression of Interest and must be signed and sealed by the Authorized Signatory with his usual signature.
- iii. The signatory of the EOI should be authorized to sign and submit the EOI to bind the Company/Firm in the matter and must sign Expression of Interests with the legal name of the Company/Firm.
- iv. Each page of EOI must be numbered consecutively and signed & stamped, as a token of acceptance of all terms and conditions.

**7. Place for submission of Expression of Interest:**

## **8. General Terms & Conditions:**

- i. NHRDF reserves the right to accept or reject any offer of Expression of Interest received from the Applicants without assigning any reasons whatsoever.
- ii. Final selection of Manufacturer/Suppliers from amongst the panel for participating in any tender will be done at the discretion of NHRDF and the decision of NHRDF shall be final and binding on all the empanelled parties.
- iii. Selection in the panel at no point of time guarantees any award of work by NHRDF through this empanelment and the Manufacturer/Suppliers who fails to get the opportunity shall not have any right to claim any damages whatsoever against NHRDF.
- iv. The Manufacturer/Suppliers may clearly note that terms and conditions enumerated in this EOI are only illustrative and not exhaustive. The chosen Manufacturer/Suppliers from the panel will have to enter into agreement as devised by NHRDF to fully protect NHRDF's overall interests and also the interests of the prospective customers.
- v. No press advertisement shall be issued for the updated Corrigendum/ Addendum. Prospective manufactures/suppliers are therefore advised to regularly visit the website of NHRDF to update themselves.
- vi. Whenever there is any inquiry from any Customer for supply of above-mentioned products/items, NHRDF will seek offer from one or more Manufacturers/Suppliers from amongst the panel at NHRDF's sole discretion.
- vii. The Manufacturer/Suppliers, whose quotation/offer is accepted by NHRDF for quoting further against tenders of its customers, shall not submit any other offer directly/ indirectly or through any other PSU/Company in the same tender.
- viii. NHRDF service charges may vary from product to product which shall be decided at the time of agreement.
- ix. The prospective Manufacturer/Suppliers can also be asked to furnish additional documents / confirmation in connection with verification of the documents submitted by the supplier, if deemed necessary.
- x. The validity of this empanelment shall be initially for one year which may subsequently be extended further on year to year after review of previous performance and at the sole discretion of NHRDF. NHRDF also reserves the right to reduce the validity of the panel at their sole discretion.
- xi. The empaneled Manufacturer/Suppliers shall ensure compliance of all the Government Regulations/Conventions/Policies/Guidelines/Orders etc. in force related to any or all of the products activities/covered in the EOI.

**9. Ownership of EOI Documents and Information Therein:**

All Expression of Interest documents will become the property of NHRDF upon submission. Where the prospective manufacturer/supplier believes that information provided in response to this EOI is, or should be kept confidential; or disclosure of this information would unreasonably affect manufacturer/supplier's business affairs, notice is to be given at the time of delivery of the information or documents by clearly marking such information 'confidential'. In so far as is practicable NHRDF will give effect to the Prospective Manufacture/Supplier stated wishes, and requests for access to such information will be determined by NHRDF.

**10. No Contractual Obligation:**

NHRDF is not bound contractually or in any other way to any prospective manufacturer/supplier of this Expression of Interest. NHRDF is not liable for any costs of compensation in relation to the consideration of this Expression of Interest or any cost incurred by the prospective manufacturer/supplier for this Expression of Interest whether or not NHRDF terminates, varies, or suspends the Expression of Interest process or takes any other action permitted under this Expression of Interest, including consideration of concepts proposed in future developments.

**11. Indemnity:**

The applicant shall keep NHRDF indemnified at all times against any claims/liabilities /proceedings, etc. from any third party or otherwise arising out/ or in connection with this EOI.

**12. Execution of Agreement:**

Separate specific agreements post award of work shall be executed between NHRDF and the Applicant on Non-Judicial Stamp Paper of Rs. 100/-. The terms and conditions enumerated in the EOI shall form the part of the agreement. NHRDF reserves the right to change or alter the terms and conditions of the Service Level Agreement post award of the work and terms and conditions of the Service Level Agreement shall prevail over the EOI.

**13. Force Majeure:**

- i. Should any extra-ordinary and unforeseen circumstances arise, like fire, flood or any other natural calamities, strike, riot, civil commotion, pandemic, epidemic, plague, accident and/or war preventing either contracting party from fully or partially carrying out the obligations under the contract, party so prevented shall inform in writing the other party of the causes of such failure within 3(three) days from the beginning thereof and shall not be liable for performance of the contract wholly or to the extent of non-performance, as the case may be. The authorities concerned of the respective countries shall authenticate prevalence of such circumstances.



- ii. For purposes of this Clause, “Force Majeure” means an event beyond the control of the Successful bidder and not involving the Successful bidder’s fault or negligence and not foreseeable. If a Force Majeure situation arises, the successful bidder shall promptly notify in writing of such conditions and the cause thereof within 48 (Forty-Eight) hours. Unless otherwise directed by the Purchases in writing, the Successful bidder shall continue to perform its obligations under the Contract as far as is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- iii. The decision of NHRDF on determination of Force Majeure shall be final and binding upon supplier.

**14. Notices:**

Any notice, request, or consent made pursuant to this Contract shall be in writing and shall be deemed to have been made when delivered by post/e-mail/hand delivery under acknowledgment to an authorized representative of the respective Parties. However, where such communication is by way of e-mail, the same shall be only from the official e-Mail ID(s) followed by written confirmation duly signed by authorized signatory.

**15. Applicable Law Jurisdiction and Dispute Resolution:**

- i. The EOI document shall be constituted and the legal relation between the parties hereto shall be determined and governed according to the laws of Republic of India and only courts at Delhi and the High Court at Delhi shall have the jurisdiction in all matters arising out of/ touching and/or concerning this agreement and parties to this agreement agree to irrevocably submit to the exclusive jurisdiction of those courts for purposes of any such proceeding. The aforementioned exclusive and irrevocable jurisdictions of aforesaid courts are irrespective of place of occurrence of any cause of action pertaining to any dispute between the parties.
- ii. All or any disputes arising out or touching upon or in relation to the terms of this tender document and process thereof including the interpretation and validity of the terms thereof and the respective rights and obligations of the parties shall be settled amicably by mutual discussion failing which the same shall be settled through arbitration. The arbitration proceedings shall be governed by the Arbitration and Conciliation Act of 1996 (as amended up to date) or any statutory amendments/ modifications thereof for the time being in force. The venue of the arbitration shall be at New Delhi, India and language of arbitration shall be English.
- iii. Nothing contained in this clause shall prevent the NHRDF from seeking interim injunctive relief against the intending Applicant in the courts having jurisdiction over the parties.

**16. Disclaimer:**

The issue of this document does not in any way commit or otherwise obliges NHRDF to proceed with all or any part of an EOI process. The EOI Request is not the subject of any process contract or any contractual obligations between NHRDF and prospective Manufacturer/Supplier. NHRDF may, at its absolute discretion, elect to abandon any part or whole of the process without giving prior notice to the prospective applicants.

**17. Interpretation of the clauses In this EOI:**

In case of any ambiguity/ dispute in the interpretation of any of the clauses of this EOI, NHRDF's interpretation of the clauses shall be final and binding on successful applicants.

**18. Integrity Pact:**

The Successful bidder will be required to sign Integrity Pact. It will be assumed that successful bidder have gone through the Integrity Pact and have no objections whatsoever in signing the contract.

**19. Holiday Listing:**

NHRDF's policy for Holiday-Listing, which is available on the website of NHRDF must be acceptable to the bidders. Notwithstanding anything contained in this EOI documents is mutatis mutandis applies to this and in the event, the agency(s) while discharging its obligations under the Agreement or otherwise, come(s) within the ambit of the said policy, NHRDF at its sole discretion reserves the right to suspend/discontinue dealings or take any curative measures with agency (s) in accordance with the policy in force.
